## 2. Included Services and Accommodation Modality

### Conference

Includes access to all academic activities, 2 lunches, coffee breaks, and a welcome cocktail reception.

### Full Experience (Conference + accommodation and additional services)

Includes access to all academic activities, 2 nights of accommodation in a double room, 2 breakfasts, 2 lunches, gala dinner, coffee breaks, and a welcome cocktail reception. Published rates are in U.S. dollars and correspond to the price per person in a double room.

Participants who wish to request a single room must contact: **edhucaconferencia@edhuca.edu.uy** directly in order to receive the corresponding quotation and coordinate the reservation manually, subject to availability.

For registrations under the Full Experience modality, accommodation will be provided in shared double rooms. If a participant wishes to share a room with a specific person, they must indicate this at the time of registration by providing that person's full name. Room assignments will be subject to the other person also completing their registration. If no preference is indicated, the organization will assign rooms, seeking to accommodate participants with others of the same sex.

## 3. Cancellation and Refund Policy

- Cancellations made up to **July 23, 2026 (inclusive)**: 75% of the amount paid will be refunded.
- Cancellations made between **July 24, 2026 and October 6, 2026 (inclusive)**: 50% of the amount paid will be refunded.
- Cancellations made as of **October 7, 2026**: no refunds will be issued.

In all cases, cancellation requests must be submitted in writing to the official event email address. Refunds will be processed using the same payment method originally used, deducting any applicable bank fees and administrative costs. Registrations are non-transferable.

## 4. Program Modifications

The organization reserves the right to modify the program, speakers, schedule, or venue due to force majeure or unforeseen circumstances, without generating any right to a refund.
